**All entry fee checks or money orders (US funds) are to be made payable to CAPER.**

One check is sufficient for all enclosed entries.

Entries are to be mailed to:

Entries must be received by **6 pm CDT Wednesday June 1**, after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is acceptable) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the American Kennel Club.

All entries must be on official AKC entry forms. Entries will be not be accepted if they are illegible, incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient fees will have the entry cancelled; acceptance of such an entry will only be made if the full fees, plus a \$25 administrative fee, are paid via certified check or money order & received prior to the start of judging. Express & certified deliveries must include signature waiver permitting them to be left at the Secretary's address without receipt signature. **Entries received without signature release will be refused.** There is no charge for changes or cancellations of entries prior to the closing date/time.

Entries will be acknowledged with an email receipt. Confirmations and judging schedules will be emailed after closing. If you want a hard copy confirmation mailed, please note this on your entry. CAPER is not responsible for non-delivery of emails due to delivery errors or spam blockers, and no further efforts will be made.

**Refunds:** Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by the Event Committee; or in the event that extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the Event Committee make it impossible to open or complete the show/trial. Refunds will be given for bitches entered in obedience or rally who come into season after the closing date, if written notice is given to the Secretary at least 30 minutes prior to the start of judging of that event's classes. Refunds of less than \$5 will not be made.

**Fax/email entries:** Entries may be faxed to the Secretary at 206-222-2830, or emailed to secretary@caper-dogs.com. Both sides of each entry form must be included, completely filled out and signed, or the entry will not be accepted. Payment can be made via PayPal or credit card by going to [www.caper-dogs.com/PayPalCCpayment.htm](http://www.caper-dogs.com/PayPalCCpayment.htm) and following the instructions there. **Payment must include the \$2 per class additional charge to be valid.** Entries are complete when both entry form and payment are received.

**Online entries:** Go to [www.caper-dogs.com](http://www.caper-dogs.com) and click on the Online Entry link.

**Entry errors:** Exhibitors are responsible for the correctness of entries. All entries which include an email address will be sent an entry verification email shortly after receipt. All errors will be corrected prior to closing; exhibitor errors discovered after closing cannot be corrected. Overpayments of less than \$5 per dog will not be refunded.

**Transfers:** Dogs which, according to their owner's records, have completed the requirements for a championship, or higher level in the other events after the closing of entries for these events, may be transferred to the higher class. Each of these transfer requests must be made to, and accepted by, the Secretary at least 30 minutes prior to the start of the event's judging.

Award of Merit : At the judge's discretion, an Award of Merit may be given to 10% (rounded up) to those competing for Best of Breed (numbers to include Winners Dog/Bitch and Non-Regular class winners). Award of Merit winners will be selected after BOB, BOS, BOW and Selects are awarded.

Reserve Winners Dog & Bitch will receive 3 championship points if the total entry in each sex is at least twice the number of entries needed for a 5 point major at this show.

### Non-Regular Classes (single dog entries) - divided by sex

Winners from each class will compete for Best of Breed.

Veteran classes  
7 years & under 10 years • 10 years & under 13 years • 13 years & over  
Veteran class entrants may be altered

Working class

Entrants must have earned an AKC Earthdog title (Novice Earth Dog title does not qualify for entry).  
Working class entrants must be intact.

### Non-Regular Classes (multiple dog entries)

Winners of these classes are not eligible to compete for Best of Breed.

Stud Dogs      Brood Bitches

Dogs/Bitches (may be altered) shown with two of their offspring. Class is judged on the merits of the offspring, but the parent will be examined for DQs/excuses. Offspring must be entered in some other conformation class. Entry is made for the Stud Dog or Brood Bitch - offspring are not entered on the entry form.

Brace Class

For two dogs, regardless of sex, performing in unison and presented by one or two handlers. Both dogs in each Brace must have at least one common owner. Entrants must be entered in some other class, and each must be on a separate entry form. Champions of record and altered dogs may be entered.

Team Class

For four dogs, regardless of sex, performing in unison and presented by up to four handlers. All dogs in each Team must have at least one common owner. Entrants must be entered in some other class, and each must be on a separate entry form. Champions of record and altered dogs may be entered.

Breeder Class

For 3-5 dogs, regardless of sex, each handled separately. All dogs must have at least one breeder in common who must be present to accept the award. Each dog must be from at least two different combination of parents, but need not be owned by the breeder. Entrants must be entered individually in some other conformation class. Each dog must be entered on a separate entry form and all forms submitted together.

### Best Bred By Exhibitor, Best Veteran, Best Working, Best Otter Head

First place in each BBE class will compete for Best BBE. First place in each Veteran class will compete for Best Veteran. Winners of the Working Dog and Working Bitch classes compete for Best Working.

Best Otter Head is open to all conformation and performance entries at the Specialty. The judge will select that entry whose head best fits the breed standard. There is no entry fee for this competition.

## SWEEPSTAKES

### Puppy Sweepstakes

Puppy Sweepstakes is open to all Border Terriers who are 6 months but less than 21 months old on the day of the sweepstakes. Entrants must also be entered in one of the regular classes at the regular entry fee.

*Classes divided by sex*

Junior, 6 mos & under 9 mos  
Junior, 9 mos & under 12 mos  
Senior, 12 mos & under 15 mos  
Senior, 15 mos & under 18 mos  
Senior, 18 mos & under 21 mos

Best Junior in Sweepstakes and Best Opposite Junior in Sweepstakes will compete with the Best Senior in Sweepstakes and Best Opposite Senior in Sweepstakes to determine the Best and Best Opposite in Sweepstakes.

### Veteran Sweepstakes

Veteran Sweepstakes is open to all Border Terriers who are at least 7 years of age on the day of the Sweepstakes. Entrants may be altered and need not be entered in another class.

*Classes divided by sex*

7 years & under 10 years  
10 years & under 13 years  
13 years & over

### DISTRIBUTION OF SWEEPSTAKES PRIZE MONEY

20% of total entry fees will be retained by Club for expenses.

The remaining 80% (for each Sweepstakes: Puppy & Veteran) will be awarded to the class placements, based on the entry fees for each class as follows:

First Place - 50% • Second Place - 25% • Third Place - 15% • Fourth Place - 10%.

All cash prizes rounded to nearest dollar amount. Undistributed funds revert back to Club.

### SWEEPSTAKES RULES

Indicate the Sweepstakes Class, with age division, in the space provided for Additional Classes on the entry form. Champions of record are eligible to compete.

Professional handlers\* may only enter and exhibit in Sweepstakes with dogs that they have officially bred or currently own or co-own. The professional handler/owner may not delegate the exhibition of his/her entry to an associate or another professional handler, and if so is subject to disqualification either at the show or retroactively.

*\*Professional handler is defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*

## JUNIOR SHOWMANSHIP

Novice class: For junior handlers aged 9-17 who, at the time entries close, have not won three first place awards, with competition present, in a Junior Showmanship Novice class at a licensed or member show.

Open class: For junior handlers aged 9-17 who, at the time entries close, have won three first place awards, with competition present, in a Junior Showmanship Novice class at a licensed or member show.

Master class: For junior handlers aged 9-17 who, at the time entries close, have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

PLEASE NOTE: Juniors must include their AKC Junior Handler number on the entry blank. Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form. Dogs shown in Junior Showmanship may have Full or Limited AKC registration or have an ILP/PAL number. Altered animals are eligible to be shown, but bitches in season are not eligible.

## FOUR-TO-SIX MONTH BEGINNER PUPPY COMPETITION

The Four-to-Six Month Puppy competition shall be for Border Terriers who are four months of age but under six months on the day of the event. An AKC registration number or an AKC litter number will be required for each entry. A foreign born dog may enter this class if they are registered in the country of origin.

- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers are not permitted to exhibit in this class. Professional handlers are defined as any person who belongs/has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last 5 years.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers who are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in this class.
- All entries must be received by the closing date. No entries will be taken at ringside.
- Exhibitors should plan on opening the mouth of their puppies for the judge.
- Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this competition.

## BORDER TERRIER CLUB OF AMERICA, INC. ROOM RESPONSIBILITY POLICY

The Border Terrier Club of America, Inc. has adopted the following rules in order to insure that its members and their dogs will be welcome at hotels in the future.

Any individual attending a BTCA sanctioned event and staying in a hotel, motel, inn or campsite/fairground has the responsibility of leaving that room or campsite exactly as found. This includes picking up after dog(s) on the grounds. Anyone who damages a room or campsite/fairground and does not report the damage to the hotel/campsite/fairground management, and make immediate restitution or arrangements to do so within a period of time agreed upon by the management, will be subject to any or all of the following actions by the BTCA Board of Directors.

1. May be banned from showing at the next BTCA sanctioned event(s).
2. May be subject to AKC sanctions.
3. Membership in the BTCA may be terminated and may not be allowed to be reinstated.

Damages shall be defined as:

1. Flea infestation, urine, defecation and/or any damage to hotel/campsite/fairground property (walls, bedspreads, carpets, drapes, etc.).
2. Any verified complaint by the host hotel/campsite/fairground.
3. Any verified complaint by a BTCA member.

BTCA Room Regulations:

1. All dogs shall be crated and quiet when left alone in a room. Noisy dogs shall be quieted upon request, even if this means the owner/handler must stay in the room with the dog.
2. Individuals will be expected to immediately report any damage to the hotel/campsite/fairground management, and to assume complete financial responsibility for those damages.
3. No bathing/grooming is allowed in rooms. A grooming room will be available whenever possible.
4. Dogs are to be allowed on hotel furniture/beds ONLY if the furniture is covered with protective covering provided by the owner/handler.
5. All owners/handlers will take preventative measures to assure that their dogs are free of fleas, mites, intestinal parasites and other communicable diseases prior to arriving at the hotel/campsite.

THIS POLICY WILL BE INCLUDED IN THE SPECIALTY GUIDELINES AND BE REQUIRED TO BE INCLUDED IN THE PREMIUM LIST WITH THE UNDERSTANDING THAT SIGNING THE ENTRY FORM ALSO INSURES COMPLIANCE WITH THIS POLICY. THE POLICY WILL ALSO BE INCLUDED IN THE SPECIALTY PACKET MAILED TO MEMBERS AND WILL BE DISTRIBUTED WITH SPECIALTY HOSPITALITY PACKETS. ALL INDIVIDUALS ARE REQUIRED TO COMPLY.

### EXHIBITORS PLEASE NOTE! THE FOLLOWING PERTAINS TO ALL EVENTS!

**RINGSIDE:** Dogs may arrive at any time prior to their scheduled time of judging. Judges will not wait for any dog. Owners and agents alone are responsible for the presence of their dogs at ringside when their class is called. The club, judges, stewards and secretary have no obligation or responsibility to announce for or locate dogs that are not at ringside when required.

**LIABILITY:** It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made. The club, hotel, and any of their agents or employees will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property, & further assume no responsibility for injury to children.

Exhibitors should follow their Veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Dogs found in an unsafe environment, distress or harm's way (for example: left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment. All persons attending this show hereby waive any claim for damages against the host clubs in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented conditions.
